# Panoramica del Regolamento sui PRIIP - Documenti Contenenti Informazioni Chiave

Il Regolamento UE n. 1286/2014 sui prodotti d'investimento al dettaglio e assicurativi preassemblati (Regolamento "PRIIP" o "PRIIP") è entrato in vigore il 1° Gennaio 2018. Il Regolamento stabilisce che gli ideatori dei prodotti d'investimento elaborino e conservino Documenti contenenti informazioni chiave (KID) e che le persone che forniscono consulenza o vendono PRIIP forniscano agli investitori al dettaglio residenti nello Spazio Economico Europeo (SEE) tali documenti (KID), affinché gli investitori possano meglio comprendere e confrontare i prodotti.

Il regolamento si applica sia agli ideatori che ai distributori di PRIIP. La responsabilità di elaborare e conservare il documento ricade sull'ideatore del prodotto. Tuttavia, qualsiasi distributore o intermediario finanziario che vende o fornisce consulenza sui PRIIP a un investitore al dettaglio, o che riceve un ordine di acquisto di un PRIIP da parte di un investitore al dettaglio, deve fornire all'investitore il KID. Ciò è valido anche per le operazioni execution-only, in modalità online.

Gli investitori al dettaglio residenti nello SEE dovrebbero ricevere il KID prima che investano in un PRIIP. Se l'ideatore non dispone del KID, il PRIIP sarà escluso dalla commercializzazione con i clienti al dettaglio dello SEE.
